**The Ministry of Session**

- The Elders gathered in the Coffee House at 6:33 p.m. for the September Stated Meeting of Session. The meeting was called to order by the Moderator, Rev. Craig, who presented the Devotion and opened the meeting with prayer.

**Approval of Minutes**

- **Motion Kester/Second Powell** to approve the Minutes of the Stated Meeting of Session of August 27, 2024. Motion passed.

**Clerks Report**

- Clerk's Report was accepted as presented.

**Motions for Discussion and Vote**

- **Piecemakers' Endowment Request – Motion Smith-Davis/Second Sales** to authorize a two-part request to Endowment for funding as follows: 1) Up to \$12,000 from the Torgerson Fund for asbestos mitigation and installation of new flooring in the Sewing Room; and 2) \$2,000 from the Torgerson Fund for the purchase of fabric, batting and various sewing essentials. Motion passed.
- **Children's Ministry Check-in System – Motion Cose/Second Kester** to authorize a request to Endowment for funding in the amount of \$1,600 from one of the Christian Education specific funds to purchase I-Pads, label printers and I-Pad stands for use in a new check-in system for the Children's Ministry. Rev. Craig advised this new system will enhance WPC's ability to serve the families of our church community by creating a more organized and secure check-in process. Motion passed.
- **Supplemental Calvin Grant Funding – Motion Sales/Second Powell** to authorize a request from Endowment for funding up to \$3,000 to assist in marketing and promoting the various components of the Calvin Grant, including, marketing efforts (such as flyers, posters and banners and digital marketing efforts such as media ads and email campaigns), promotional

events and activities, and other similar expenses incurred on behalf of the project. Motion passed.

- **Property** – Kester reported that scaffolding will be going up in the Sanctuary soon for light bulb replacement.
