- **Christian Education** – A special subcommittee is studying the Confirmation process. The 2<sup>nd</sup> Trunk or Treat is scheduled for Sunday, October 27 from 2-4 p.m. Online interest has been around 850 persons as of the Session meeting date.
- **Finance** – Greve reported that receipts are still slightly in excess of expenditures through September.

- **Mission** – Fabrizio reminded the Elders that Nomination Forms are being solicited through early November for The Blessing and encouraged reaching out to any non-profits that Elders might want to encourage to submit a form. Christmas Dinner volunteers are needed and Elders were encouraged to contact Fabrizio if they are able and willing to assist.
- **Nominating** – Nominating has been meeting to fill open positions for 2025.
- **Property** – Kester thanked the volunteers who recently replaced all of the bulbs in the Sanctuary and other areas of the church. The snow removal contract for this winter is in place.
- **Stewardship** – October 27<sup>th</sup> is the beginning of the Stewardship campaign. The Campaign is being chaired by Harrison Cass.
- **Worship & Music** – Planning for the Holiday season and Advent is underway.

- Clauson advised that there is a new policy being presented at the upcoming November Presbytery meeting regarding the procedure to be followed when a church is dissolved. She also reported there are General Assembly Overtures that will be voted on at a later Presbytery meeting. Clerk will locate a summary of such matters to distribute to the Elders.
